foreword

HAPPY BIRTHDAY, HCWH EUROPE!

Is it really 10 years since Health Care Without Harm established an office in Europe? I still remember the first time I learned about HCWH and the proposal to start a European branch sometime in 1999 or 2000. I was just one representative of several international organisations meeting in Geneva at the very last preparatory meeting before the Stockholm Convention. It was my first time at such an international conference.

The HCWH offer was proposed over a dinner gathering and it sounded like a fairytale: "We have been offered money from a foundation to carry on work on a global scale. So we want to set up new branches of HCWH on every continent. You just propose a project, we provide the money!"

These were thrilling times for Europe: the Iron Curtain had broken down only 10 years prior to then and everything seemed possible in the former Eastern Bloc countries. Civil society there needed a boost and just a little seed money had a tremendous impact. So it was not a surprise that at first an office was established in Prague and early projects mostly focused on Central and Eastern European countries. This had been a great time generating expertise and building strong networks.

In these early times the Viennese Hospital Association was also quite active in the movement and hosted the first CleanMed in Europe in 2004. This conference was really an eye-opener for me. Never before did Lattend such a kind of conference that at the same time served as





an industry fair for sustainable healthcare products. The strong exchange between science, civil society and industry left a lasting impact indeed. Visiting this conference clearly taught participants about the grave responsibility of the healthcare sector for our environment - you cannot pretend to care for health if you do not care for the environment. And besides, the sector is a big economic player that has to recognise its share in global responsibility.

What followed were the difficulties after a strong beginning: American foundation income dwindled because of weak exchange rates and the economic crisis. European member organisations were used to receive money for their own projects but were not educated to support HCWH Europe in return. Some of them were disappointed. It was only at that time that I was invited to step onto the board. I saw tiring struggles with the building of a new office structure and a long and often frustrating fight for sufficient funding sources. But there is light at the end of the tunnel. Finally the organisation succeeded in securing EU funds. The current Executive Director, Anja Leetz, was able to build a strong team working now at an office in Brussels and well placed in the midst of European politics. I put my faith in that team and in the ongoing projects to light the way to a more sustainable healthcare in Europe.

NEW PROJECT

A database for non-incineration alternatives was launched on the HCWH Europe website. It listed vendors and facilities where these technologies were implemented.

POLICY BREAKTHOUGH

HCWH Europe was appointed as the only NGO to a working group set up by the Czech Environmental Ministry that prepared a waste management plan for hospital waste throughout the country.

POLICY BREAKTHROUGH

As a result of a scientific report and subsequent lobbying, HCWH Europe was successful in convincing the EU to ban new mercury thermometers and look closer into other mercury containing devices.

POLICY BREAKTHOUGH

HCWH Europe was successful in convincing EU Ministers of Health to consider amendments regarding the environmental impacts of pharmaceutical disposal on human health and the environment. Denmark, Belgium, Sweden, Finland, Austria all responded positively and supported these amendments.

POLICY BREAKTHOUGH

After the release and accompanied lobbying of HCWH Europe's report on phthalates in cosmetics "Pretty Nasty", the EU Parliament adopted amendments to the Council Directive which bans carcinogenic, mutagenic or reprotoxic substances (CMRs) in Cosmetics.

As a result of a seminar co-organised with the Vienna Hospital Association on the adverse health effects of DEHP on specific patient populations, the neonatology unit of the paediatric clinic in Glanzing, Vienna became the first neonatology unit worldwide to announce it would manage completely without PVC.







IT BEGAN IN 1999 when a group of committed non-government organisations came together united by the idea that the healthcare sector can do much more to ensure the health of the environment and that of its patients. After some initial projects, they decided to establish Health Care Without Harm (HCWH) Europe in order to better tackle these issues at a European level.

On the 10th April 2003, HCWH Europe registered as a European NGO in the Netherlands. From there, HCWH Europe began to take shape. They established a main office in Prague, drafted a constitution, elected a Board of Directors, appointed an Executive Director, Steering Committee and three Working Groups and the first board meeting of HCWH Europe was held in Prague on 15th March 2003.

AFTER A GROUND BREAKING YEAR SETTING UP such a unique organisation, the team behind HCWH Europe built on their successes and welcomed 2004 with vigour. They focused on a range of vital issues as well as organising the very first CleanMed Europe conference in Vienna, Austria.





As a result of the medical device campaign, the German Federal Institute for Drugs and Medical Devices has recommended the use of DEHP-free alternatives for specific patient groups and Swedish hospitals have agreed to stop using PVC tubing and IV bags in neonatal intensive care units.

HCWH Europe wrote and distributed another report - Non-Incineration Medical Waste Treatment Technologies in Europe at the 4th Ministerial Environment and Health Conference.

REPORT/RESEARCH



HCWH Europe tested 48 common medical devices used in hospitals in Austria, the Czech Republic, France, Germany, Poland, Spain and Sweden for the presence of the phthalate DEHP. The tests showed that common medical devices made of PVC plastic contained between 17% and 41% of phthalates by weight.

The report - Preventing Harm from Phthalate, Avoiding PVC in Hospitals - was first presented at the 4th Ministerial Conference on Environment and Health organised by WHO Europe and strongly supports the elimination of this chemical from all healthcare products.

Whilst at CleanMed Europe, hundreds of people signed the "Vienna Declaration of Environmental Standards for Healthcare Facilities". The declaration called for binding environmental standards and specified concrete goals to be achieved.

HCWH Europe tackles waste management

HCWH Europe became a conditional member of the Medical Devices Expert Group (MDEG) working on the issue of PVC/DEHP. With active advocacy and engagement in the amendment process for the Medical Device Directive, HCWH Europe welcomed the news that medical devices containing DEHP needed to be labelled.

NEW PROJECT +



HCWH Europe produced www.greeninghealthcare.net and the XCHANGE database as a key European web portal for healthcare facilities. Healthcare professionals could find essential information on PVC, mercury, hospital waste, pharmaceuticals, transport, laundry as well as individual case studies from hospitals on how specific problems and projects were addressed and solved.

A new network of environmental managers from hospitals in Sweden and Denmark was established at a meeting organised by key HCWH Europe members.

HCWH Europe was involved in a consultation process that resulted in a EU commitment to partly revise the Scientific Committee mandates to include more effort to recruit external scientists.

AFTER FIVE SUCCESSFUL YEARS since officially forming, 2008 had a few changes in store for HCWH Europe. Our Prague office came to a close, the Executive Director Cestmir Hrdinka moved on, followed by Jamie Page and changes in the by-laws were made. Just like 5 years earlier, the future was unknown but the potential and drive behind the organisation was loaded.

HCWH Europe helped defeat an international candle standard, which would have resulted in more environmentally hazardous, brominated flame retardants being unnecessarily added to the casings of electrical devices such as televisions and computers.

HCWH Europe contributed to the development of the Nordic Swan eco-label criteria for medical devices - the first time an eco-label had been proposed for a medical device. The device had to be PVC-free to qualify for certification.

AS TEMPERATURES SOAR, sea levels rise and the global populace become more informed, climate change cannot be denied any longer. Nor can the potentially devastating impacts climate change will have on public health. In 2011, HCWH Europe continued to advocate for stronger action from all stakeholders to reduce their climate footprint and to increase their mitigation and adaptation efforts.







Following on from the Global Green and Healthy Hospitals Agenda, the GGHH network was launched. The network consists of hospitals, health systems and organisations seeking to implement and evolve the Agenda by charting progress in achieving measurable outputs, while sharing best practices and finding solutions to the challenges they share.

Partnering with the Region Skane and TEM, the 3rd CleanMed Europe took place in Malmö, Sweden. Over 350 participants from 34 countries and 5 continents and 22 exhibitors took part.

POLICY BREAKTHROUGH



France passed a law that for the first time banned the use of tubes containing di(2-ethylhexyl) phthalate (DEHP) in paediatrics, neonatology and maternity wards in hospitals.

REPORT/RESEARCH



HCWH Europe launched their "Healthy & Sustainable Flooring, choosing resilient flooring for the European healthcare sector" report – available in 5 languages (EN, FR, DE, ES, PT).

The mercury column sphygmomanometer will soon become an historical relic in Europe.
