THE ISSUES WE WORK ON

SAFER CHEMICALS

The ubiquitous exposure to man-made synthetic chemicals in everyday life has increasingly become a health concern. Unfortunately, many products used in healthcare can also contribute to hazardous exposures.

Healthcare institutions have a particular ethical responsibility to use products containing chemicals that pose less risk to human health. Due to its massive purchasing power, the healthcare system can play a key role in shifting the economy towards green chemistry.

Our work on chemicals revolves around:

- Endocrine Disrupting Chemicals (EDCs)
- Mercury
- Nanomaterials and nanomedicine

CLIMATE & ENERGY

Greenhouse gas emissions are resulting in increasingly common environmental disasters and public health consequences - leading to a growing awakening amongst medical professionals and healthcare providers. Climate change has a range of complex health impacts including temperature-related health complications and death, injuries and illnesses due to extreme weather events, the spread of infectious disease vectors, increases in water borne illnesses, and a wide range of health complications from air pollution.

Our climate and energy work focuses on three key pillars:

- **Mitigation** - Reducing healthcare's own carbon footprint and fostering low carbon healthcare
- **Resilience** - Preparing for the impacts of extreme weather and the shifting burden of disease
- **Leadership** - Educating healthcare staff and the public while promoting policies to protect public health from climate change

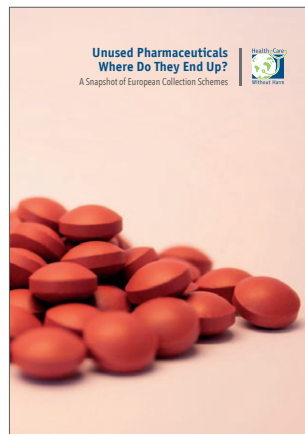


PHARMACEUTICALS

Pharmaceutical residues are found in the environment throughout the world and the harm these might be doing to human health and the environment is increasingly concerning. In Europe, ageing populations, newly emerging diseases, and a general growing dependence on pharmaceutical drugs are increasing the demand for pharmaceuticals and an increase in medicine consumption is expected; **pharmaceuticals are a priority area from an environmental health perspective.**

HCWH Europe's pharmaceuticals work is divided into two defined sub-issues:

- Pharmaceuticals in the environment
- Antimicrobial resistance (AMR)

Sustainable food procurement and reducing food waste in healthcare improves the quality of patient care whilst reducing costs and environmental impacts

HEALTHY & SUSTAINABLE FOOD

Healthcare facilities across Europe are recognising that food systems (how our food is produced and distributed), are misaligned with dietary guidelines, and are largely reliant on methods of production and distribution that harm public and environmental health.

Furthermore, the poor quality of food served in many of Europe's hospitals has become a cause for increasing concern as the links between an unhealthy diet and serious medical conditions have become blatantly clear.

By adopting sustainable and healthy food policies, healthcare organisations demonstrate a commitment to HCWH's mandate - first, do no harm. They recognise that aligning their public procurement strategies with such policies helps provide better quality meals and reduce food waste - protecting the environment, saving money, and improving the health of patients, staff, and communities.

SUSTAINABLE PROCUREMENT

With 2.8 million hospital beds and 12,990 hospitals, the European healthcare sector is a major public purchaser of goods and services. In the process of treating patients, the healthcare sector consumes large amounts of energy and water, as well as disposable products, building materials, pharmaceuticals, and medical devices.

Sustainable Procurement is the practice by which authorities, including hospitals and health systems, address green and social/ethical considerations in their purchasing practices. **By implementing sustainable procurement strategies, such as applying green and social criteria to tendering processes, hospitals can improve their environmental footprint and become socially responsible, as well as managing their way towards long-term change.**

Pharmaceuticals in the environment are a global problem – more than 600 pharmaceuticals and their metabolites have been found in the environment worldwide. They enter the environment (through water, soil, sludge, and organisms) at all stages of their life cycle and can end up in drinking water, and accumulate in fish, vegetables, and livestock.

The aim of the Safer Pharma campaign is to protect the environment from pharmaceutical pollution at all stages of their life cycle.

- Four regional offices (based in Buenos Aires, Brussels, Manila, and Washington, DC) that develop regional work and initiatives in Latin America, Europe, South East Asia, and the United States, respectively. A Global staff also facilitate programs with global impact, including (but not limited to) Global Green and Healthy Hospitals - a worldwide network of hospitals and health systems acting together for environmental health.

- Strategic partners that represent our interests and lead the development and implementation of HCWH-related work in Australia, Brazil, China, India, Nepal, and South Africa.
- Practice Greenhealth, a nonprofit health care sustainability membership organisation, and Greenhealth Exchange, a green purchasing cooperative, both based in the United States.

The guiding and decision-making body of HCWH, the International Council, is composed of the Executive Directors from each region, the President and co-founder of HCWH, and the International Director for Program and Strategy.
