
Introduction




- Survey sent to all European GGHH members




Members asked to rate benefits (0-5)




How do you prefer to receive information from HCWH Europe?






How often would you like to receive a memberonly newsletter from HCWH Europe?






What content would you like to see in a GGHH memberonly newsletter?






How often would you like virtual member meetings to take place?


